Under authority vested exclusively in the court by Section 479.050, Missouri Revised Statutes, 1996 and by rule 37.49, Missouri Rules of Court, 1996, it is hereby ordered that the following schedule of fines and court costs for the Violations Bureau is established. This schedule shall supersede all previous schedules of fines and costs whether established by ordinance or otherwise and shall be applicable only to those violations disposed of prior to the scheduled court appearance noted on the summons.

It is further ordered as required by Rules 37.49 that this schedule be prominently posted at the place where fines are to be paid. Payment of scheduled fine and costs shall be as follows, 12.00 Court Cost, 7.50 Crime Victims Compensation Funds, 2.00 City Police Training Fund, 1.00 State Peace Officer Training Fund, 2.00 Domestic Violence, 2.00 Inmate Security Fund, 7.00 Court Automation Fee.

Any violation not listed in this schedule requires and appearance in court unless otherwise ordered.
